- 1. The trip cost is \$2,495 and includes all of the following:
 - a. All scheduled ground transportation including airport transfers, inter-city travel and transfers within cities that are not within walking distance of the hotel. This will be on our private motor coach.
 - b. All entrance fees for visits included on the "Tentative Itinerary".
 - c. One meal, usually supper. These meals are arranged by Patrick Arensberg and will typically include two courses and sometimes dessert. Bottled water (sparkling or plain), wine in moderation for adults, and tips are all included. No other beverages are included in the cost of the tour.
 - d. Hotel accommodations: These are double rooms with private bath, or triple/quad rooms for students with private baths.
 - e. Other mandatory tips.
 - f. Full time tour conductor in Italy.
- 2. Nothing else is included in the tour cost, most notably:
 - a. Airfare: this is estimated at \$1,8,00
 - b. One meal a day (typically lunch)
 - c. Additional hotel expenses such as, but not limited to:
 - i. Fees for making calls from the room
 - ii. Fees for damage to a room
 - iii. Purchases charged to the room
- 3. Payment schedule is as follows. Failure to meet any of the payment dates subjects the purchaser to forfeiture. All payments are non-refundable. Checks are to be made payable to Chi Rho Euro and should be mailed to: 1563 Fearnway, Mobile, AL 36604
 - a. By October 1: \$500
 - b. By December 15: \$1,000
 - c. By February 15: \$500
 - d. By March 15th: \$495 plus airfare

^{**}This payment schedule is for your convenience. You are more than welcome to pay the entire balance in one payment.

- 4. If you have made some or all of the payments and become unable to travel, you may transfer your trip to someone else. Airlines' rules vary and change, and this may not be possible at all.
 - a. You are responsible for any and all fees to the airline for such a change, if the change is possible.
 - b. You will be responsible for any extra hotel fees if your transfer causes an imbalance in the rooms.
- 5. The itinerary is tentative, and not within Patrick Arensberg's control. Further, I agree to not hold Patrick Arensberg responsible if some visits on the schedule are missed for whatever reason.
- 6. Chi Rho Euro, LLC including its members, employees, contractors, agents or attorneys (collectively "Chi Rho Euro") is not responsible for any loss or inconvenience caused by a flight cancellation or missed flight due to a delay. Neither is Chi Rho Euro responsible for property that may be lost or stolen in the course of the trip. Further, I agree not to hold Chi Rho Euro responsible for any such events as described.
- 7. I hereby waive any and all claims against Chi Rho Euro and his agents or contractors, domestic and overseas, their heirs or their estate, arising from any death, irregularity, or expense to person or property incurred from the use of any vehicle or service, strikes, war, weather, sickness, quarantine, government restrictions or regulations, or arising from any act of omission of any steamship, airline, railroad, bus company, sightseeing, hotel or any other service or transporting company, firm individual or agency.
- 8. I release Chi Rho Euro and his agents from financial obligations or liabilities that I may incur or any damage or injury to me or to the person or property of others that I may cause while participating in this program, and I agree to indemnify them against any such financial obligations or liabilities that may arise as a result of my actions.
- 9. I understand that I am solely responsible for any costs arising from the loss or theft of any of my personal property during this program, including my airline ticket or passport.
- 10. I understand that it is the responsibility of each passenger to obtain a valid U.S. Passport prior to travel. This passport must not expire within 6 months of the return date.
- 11. I understand that the passenger is responsible for any damage the passenger causes to the hotel, bus or any other equipment. I agree to pay for any such damages that I may cause, and I cannot hold Chi Rho Euro responsible for these damages. Further, I will indemnify Chi Rho Euro from any claims for such damages caused by my actions.
- 12. I certify that I am in good physical and mental health, and that I have no medical conditions which would preclude my participation in the proposed trip. I have been informed that there is a great deal of walking daily, up to 4 or 5 mites. I am or will be capable of doing this walking without inhibiting the progress of the group.
- 13. I understand that if Patrick Arensberg or another Chi Rho Euro representative determine that my presence is an impediment to the group because of my physical limitations or because of my attitude I will be sent home at my expense prior to the completion of the pilgrimage. I further understand that the passenger will be accompanied to the airport but will fly home unaccompanied.

- 14. I, as a participant, agree to comply with all directions issued by Patrick Arensberg or his agents.
- 15. Anyone who wishes may arrange their own air transportation. The traveler is responsible to see that they are on the same flights that the group is on. If they end up on a different flight from the group, they will be responsible for joining the group: the bus will not be held for any such passengers, nor will the bus make a special trip to the airport to help them catch their flight home. The bus schedule will be purely predicated upon the flights arranged by Chi Rho Euro. Such a passenger will also be responsible for their own arrangements in the case of a flight cancellation.
- 16. Anyone making their own flight arrangements and payment will have the cost of the group ticket subtracted from the price of the trip.
- 17. Arrangements may be made to extend the return flight of an individual or individuals. These flight arrangements must be made through Chi Rho Euro and details will be provided to anyone who may inquire.

18. I have been offered the purchase of trip insurance. It has been strongly suggested that purchase it. I understand that there are dangers inherent with international travel.

- 19. No waiver by the parties hereto of any default or breach of any term, condition, or covenant of this agreement shall be deemed to be a waiver of any other breach of the same or any other term, condition, or covenant contained herein.
- 20. This Agreement is to be construed and governed by the laws of the State of Alabama. Each party hereto irrevocably agrees that any legal action or proceeding arising out of or in connection with this Agreement may be brought in any state or federal court located in Mobile County, Alabama (or in any court in which appeal from such courts may be taken), and each party agrees not to assert, by way of motion, as a defense, or otherwise, in any such action, suit or proceeding, any claim that it is not subject personally to the jurisdiction of such court, that the action, suit or proceeding is brought in an inconvenient forum, that the venue of the action, suit or proceeding is improper or that this Agreement or the subject matter hereof may not be enforced in or by such court, and hereby agrees not to challenge such jurisdiction or venue by reason of any offsets or counterclaims in any such action, suit or proceeding.
- 21. The Parties hereto each voluntarily, knowingly, irrevocably, and unconditionally waive any right to trial by jury of any and all claims, demands, costs, expenses, and causes of action, of any kind or description whatsoever, on account of or arising out of the Agreement. Without limiting the scope of this waiver, the Parties agree that any action to enforce or defend any right or duty under the Agreement or any other right or duty between the Parties under any federal or state statute and/or under the common law, shall be decided by a court of competent jurisdiction without a jury.
